Dear Valued Member,

We appreciate the trust you have placed in us to handle your financial needs and we recognize the role we play in providing an essential service to our community. Along with a growing number of businesses across the state, we have activated our pandemic plan in accordance with our standard business continuity practices, due to the spread of the coronavirus. Our plan provides for the ongoing health and safety of our employees, members, and community partners while ensuring seamless service operations, as well as compliance with governmental regulations and public health guidance. As a proactive, precautionary measure, we have implemented the following control measures designed to minimize the risk of impact to our services:

Service Continuity

It is out of an abundance of caution, and for the safety and well-being of Rutgers Federal Credit Union employees and members, the Busch branch will temporarily ONLY offer Drive-thru service to conduct in-person transactions starting on Wednesday, March 18, 2020. Members may temporarily use the Drive-thru as a Walk-up Service. Our College Avenue, Newark and Camden branches will be closed to our members until further notice. For members that need in-person assistance from a Member Service Representative or a Loan Officer, please call (732) 445-3050 to schedule an appointment. The credit union is operational and ready to assist with members' banking needs. Aside from calling us, please communicate with us via email at Loans@rutgersfcu.org or Info@rutgersfcu.org.

We encourage all of our members to access their banking accounts from home 24/7 using our online or mobile banking platforms. You can view your account balances and account history including recent debit card transactions and electronic deposits, like your paycheck. You can also pay bills, transfer funds between accounts, apply for a loan or open additional accounts. Using these secure digital services, you can conduct most of your banking business from the comfort and safety of your home environment.

Take advantage of Rutgers Federal Credit Union's ATM Network and the over 30,000 [Co-op Network ATMs nationwide](#). These FREE ATMs are available at most 7-Eleven and WAWA stores. You can click on the Co-op Network ATM link above to locate an ATM closest to you.

Deposits can be made using our Mobile App, Mobiliti. Mobiliti can be downloaded on your smartphone or tablet. Deposits can also be made at an ATM machine that accepts deposits with the accel or Co-op logo.
